### WEBDCU UPDATES FOR PROTOCOL V2.0

#### Screen Failure Form and Eligibility (F101)

CHA2DS2-VASc score ≥2 no longer applicable.

CHA2DS2-VASc (F304) is still required in order to stratify treatment assignment.

#### Eligibility (F101) and Randomization (F102)

Q01 (protocol version approved at time of consent) – now includes Protocol v2.

- Choose Protocol v2.0 if subject signed ICD v5.
- If subject signed ICD v4 and you are approved for ICD v5 at time of baseline visit, re-consent and randomize under Protocol v2.0; If reconsent at Baseline visit is not possible, randomize under Protocol v1.4 and re-consent as soon as possible.

#### **Informed Consent (F244)**

Q01 (Informed consent form version) is now drop-down menu of version used for initial consent.

All prior Informed Consent CRFs are consolidated to F244 with appropriate version selected.

**NEW:** Re-consent (F249) — manually posted for active subjects with previous ICF submitted.

Q01 (Informed consent form version) will automatically default to Version 5.

Only complete for re-consents; upload initial v5 consents to F244.


