

On *Holiday Shipping* days with "emergent shipments only" StrokeNet Pharmacy may not ship without speaking to someone to confirm your site is open and available to receive the package.

Emergent shipping includes 2.5 mg kits for newly randomized participants who meet criteria (i.e., at least 2 of the following conditions: Age 80+, weight \leq 60 kgs, creatinine 1.5-2.4 mg/dL).
