Consenting Talking Points

from Rustam Al-Shahi Salman, PI for SoSTART

- Discuss ASPIRE early, while on the stroke unit
- · We're doing everything possible to make you better
- We know OAC is beneficial for AF
- Many contributors to ICH (age, BP, alcohol, diet, BMI, etc.). OAC pre-ICH likely minor role
- OAC & aspirin are both standard approaches
- Promising observations of OAC for AF after ICH
- Take a balanced view of both approaches
 - o There are benefits and risks of starting and avoiding OAC
 - o Balance of risks and benefits is similar
 - \circ $\,$ So, starting or avoiding OAC are both options
- Uncertain about which standard approach to take
- Solution is ASPIRE...
 - o It could help you and your doctor with this difficult decision about OAC
 - We will monitor you if you take part in ASPIRE
