Study TIPS

- Strongly prefer that FM & ARAT are performed by PT/OT.
- FM at Visit 2 & 6 must be performed by the same person.
- Neither TMS operator nor TMS assistant should do 90-Day FM or ARAT.
- Two people should be listed for TMS Operator, TMS
 Assistant, and the Behavioral Assessments in the DOA log.

We recommend 4 team members on the VERIFY study at each site. Please refer to VERIFY Staff Roles PowerPoint slide for more details
