Key Action Items for Completion of Trainings

- Online Training modules for all study staff
- Practical TMS training on healthy volunteers
 - The last step for fast-track sites to have site readiness calls and be released to enroll!!
- TMS technique check by VERIFY leadership/ consultants for standard TMS sites
 - The last step for standard sites to have site readiness calls and be released to enroll!!

TMS Reminders

- TMS Operators need to be given the green light email from the VERIFY team before proceeding with healthy volunteer TMS training.
 - o In order to receive this green light email, the TMS Operator needs to successfully complete their 6 online TMS training modules and be listed as a TMS Operator on their site's DOA.
- All TMS operators are to upload their healthy volunteer training certificate in WebDCU under the People Document section. This is the only TMS training certificate that should be uploaded to WebDCU.
- We recommend that TMS operators complete 1 healthy volunteer TMS session & wait for feedback before proceeding with the next healthy volunteer TMS session. This way, TMS operators can incorporate feedback and make corrections before performing their next healthy volunteer TMS session.
- We also recommend re-reading the "7. TMS Source Document" and "8. Practical TMS Training with Healthy Volunteers" pages on the TMS training website before starting practical training with healthy volunteers.

- Sites should maintain their completed healthy volunteer source documentation (e.g., TMS Safety Checklist) in a binder onsite.
- Any study staff can be assigned role of TMS Operator (does not have to be PT/OT)
