# Additional Considerations

- Order of testing
  - Seated tasks first: reaching tasks, seated play session/AHA, then move onto seated Bayley tasks
  - Put lines on floor ahead of time
  - Move to free floor play to complete play session, then Bayley GM and GMFM as able
  - Day 2: Complete any remaining seated tasks from Bayley, then move to floor to complete any remaining GM Bayley and GMFM
  - Day 3 scheduled and canceled if not needed



#### **Additional Considerations**

- Have coversheets prepared ahead of time, then briefly stop camera and re-start with new coversheet when starting a new assessment.
- Have additional toys ready ahead of time to use during the GMFM.
- Use caregivers to help motivate during the GMFM and handle the child when appropriate.
- Have a second staff member assist to ensure proper recording, assist with set up, and if another trained BA is available, to help record and score items on GMFM and Bayley.
- Jot down words the child says throughout the assessment.
- Try to put stair items for Bayley and GMFM together



# Overview



- Data timeliness has always been important for trials, but new national guidance has put an emphasis on the PIs responsibility to monitor for unanticipated events that on their own do not represent a problem, but in aggregate for the trial may signal something that needs to be corrected.
- This has been an issue for other trials, and I-ACQUIRE has SOOO much data, we want to be proactive now before so much has accumulated that its hard to turn back the statistics from 'bad' timeliness.

#### Late Visits

- Visit Windows
  - Treatment visits should start ideally 1 2 days after the baseline visit but could be up to 14 days after the baseline visit.
  - Post-Treatment visit should be scheduled ideally 1 2 days after treatment but could be up to 14 days after the treatment visit.
  - 6 Month Post Treatment Assessment should be scheduled 180 days after treatment (+/- 2 months).
- WebDCU defines a window around each scheduled visit.
- For I-Acquire, since the U&CT and active subjects have different visit sequences its not possible to program the 'usual' narrow windows
- Instead, NDMC statistical programmer is generating reports from the data
  - Visit may appear 'on-time' in WebDCU, but considered late by protocol
- Tools
  - Visit calendar tool
  - Individual site report cards (in progress)



#### Data Entry Timeline

- DCRs should be responded to within 5 days
- Enter CRFs within 5 days of visit date
- Add visit within 5 days of visit
- Dismiss rule violations within 5 days
- Reported to Study team bi-weekly
- Reported to DSMB semi-annually
  - To review these violations please go to the [Data Management] tab and click on "CRF Data Entry Report". You can see how these fields are calculated by clicking on the blue number hyperlink next to your sites name.



#### Monthly Data Entry Emails

- Open DCRs

To address the rule violations, you can either edit the CRF and edit the missing data or dismiss the rule violation explaining why the data is missing. You can only dismiss warning rule violations.

  - Under the [Project Management] tab you will need to click on "COVID-19 Impact Assessment V2". Click the blue number hyperlink for your site and click "Edit Record".
- · CRFs Pending Submission
  - To review these CRFs please go to the [Data Management] tab and click on "Subject CRF List". You can filter for pending CRF by clicking on the dropdown page action list in the right-hand corner and select "Passed Validation Not Submitted". You can go straight to the CRF by clicking on the green arrow under the CRF ID column
